2. Application area and principles

This data sheet applies solely to the premises of Leipziger Messe GmbH.

Vehicles (including containers, semi-trailers, buses etc.), which are used as exhibits or exhibition stands, are subject to approval as part of the stand installation registration process. (Form A1 "Stand construction application" or online ordering system)

2.1. Exhibition of vehicles

In the case of vehicles with combustion engines:

- the fuel or gas tank must be mostly empty and closed
- in the case of exclusively electric vehicles, the drive battery must be disabled using the main switch

In the case of gas-operated engines, the gas pressure container must be reported separately (form A12 "Pressurised and liquid gas cylinders" or online ordering system).

The exhibited vehicles must be permanently and continuously looked after during visitor hours.

2.2. Vehicles as exhibition stands

If the vehicles, containers, buses, trucks, semi-trailers etc. have the effect of covering or closing (to the top) more than 30 square metres of stand space, the following is required:

- Installation of Leipziger Messe mobile fire alarms (order via order form A7 "Fire protection")
- a fire extinguisher min. 6 LE (extinguishing units) must be installed.

3. Approval

The number of fire extinguishers and smoke alarms will be determined by Leipziger Messe / Technical Event Management Department as part of the stand installation approval process once all documents have been submitted. Order via order form A7 "Fire protection"

Fire extinguishers must be held available by the exhibitor. In exceptional cases, they can be ordered from the hallinspector on location.

is granted subject to the following requirements/approval comments:

- Vehicles with combustion engines may only be parked with mostly empty and locked fuel tanks.
- In the case of vehicles with electrical motors, drive batteries must be disconnected from the drive with safety clamp connectors (main switch).
- In the event the vehicle requires the supply of electricity for presentation purposes, electricity must be supplied from an external power supply.
- Depending on the covered area, fire alarms must be installed, which are connected to the central fire alarms. Ordered using order form A7 "Fire protection".
- A minimum of fire extinguisher/s must also be kept available at the stand.
